1. Introduction at 7pm. Acceptance of Agenda, 1st: PA’s, 2nd: Grizwalds, passed
2. Acceptance of 2011 Annual Spring meeting minutes, 1st Excon, 2nd On Fire, passed
3. Presentations: The Executive presented Renee with a gift to thank her for all her hard work and also recognized the teams that helped this year while Renee was down. Executive also thanked Jenny and her team for helping out at the Provincials. Congratulations to the C&D Coed National teams. LSPUA was not in attendance but the Executive recognized that we at Langley have some of the best umpires in the country.
4. Review Who needs to reapply: e.g., Late rosters, Late payment, Forfeit Playoffs
5. **New Business:**
 - Small Ball is here for one more year due to that fact that the balls had to be ordered in September this year.
 - YET pickups – Hood brought up that NO Pick ups was not fair – No Vote.
 - # teams will be no higher than 176
 - CUPS – use them and clean up after yourselves and your team
 - Sponsor Logo – space is available on our Home Plate
 - No Fee Increase for 2012 Season
 - Forfeits – 48 hours notice will change to **5pm 2 days before**. The umpires need more notice
 - Motion: We vote BB/sb or not amended Motion: No BB/Sb and bring back bunting 1st Crazy Dutch Bastards 2nd Wrecking Crew
 - Amended to: If Female chooses BB they can bunt 1st Freightliners 2nd Sluggers DEFEATED
 - Motion: BB/sb and allow bunting – Females can choose either ball and bunt 1st Wrecking Crew 2nd Sluggers DEFEATED
 - Weather: who decides if the games are on or not? Peter makes the call if it is obvious and other wise the umpires will call it at the field
 - Bases: Noted that some are in pretty rough shape, Executive have already bought new ones for the 2012 Season
 - MAP 2 Trees overgrown and LSS/Denny Ross is to be re-skinned both to be taken care of by the Township of Langley
 - Double Header Format – Teams really enjoyed Fall schedule and would like to see more double headers during Spring – We schedule to the best of our ability given the large number of teams. Field Selection re: teams/ Div – again we do the best that we can MAP will never expand.
 - Time restrictions for games; Umpires will call the 60 minute mark: current inning will finish and only one more inning will commence after that.
